- 1. <u>Purpose</u>. To provide policy governing authorization for payment of Basic Allowance for Housing Single (BAH-S) by the Naval Station (NAVSTA) Everett Commanding Officer (CO) per references (a) through (e). This instruction is a complete revision and should be reviewed in its entirety.
- 2. Cancellation. NAVSTAEVERETTINST 7220.1C
- 3. <u>Scope and Applicability</u>. All elements of this instruction apply to all NAVSTA Everett and tenant command military personnel.
- 4. <u>Background</u>. Per reference (b), the NAVSTA Everett CO is the shore-based facility command and will determine eligibility to draw BAH-S. When adequate permanent party Unaccompanied Housing (UH) space is not available or when maximum occupancy is reached, the Installation CO may authorize unaccompanied personnel to live off base and draw BAH-S.

5. Policy.

- a. The core mission requirement of UH is to provide adequate housing for all single E-1 through E-3 Sailors onboard NAVSTA Everett; all single E-4 with less than four years of service and, based on local conditions, single E-4 with more than four years of service.
- b. Per references (a) and (e), single shipboard E-1 through E-3 and E-4 Sailors with less than four years of service are not entitled to BAH-S.
- c. Per reference (b), approval by tenant command COs for single shipboard E-4 with more than four years of service and single E-1 through E-4 shore duty Sailors to reside in the civilian community does not constitute an authorization to receive BAH-S. Single shipboard E-4 with less than four years of service, without dependents, cannot elect to not occupy assigned shipboard government quarters and receive BAH-S.
- d. Per reference (b), shipboard E-4 Sailors over four years and ashore E-4s who were previously residing in the local area will not be involuntarily assigned to UH if in receipt of PCS orders authorizing movement of household goods.
- e. Frocked service members. Per reference (d), single shipboard Sailors frocked to the pay grade of E-5 are not eligible for BAH-S until they are permanently promoted to the pay grade of E-5.
- f. Pregnant Sailors. Upon doctor's Medical Certification of Pregnancy, a single Service Member with no dependents who currently resides in UH is authorized to remain in the UH for the full term of pregnancy if the member desires. Up to her 20th week of pregnancy, an E-1 to E-4 may request, and the NAVSTA Everett CO may authorize permission for, off-base housing and draw BAH at the without-dependent rate. After the 20th week of pregnancy the member will be able to automatically draw BAH at the without-dependent rate. Upon giving birth, the member will be authorized to draw BAH at the with-dependent rate. However, the authorization for housing allowance ends if the service member does not maintain legal custody of the child.

6. Procedures.

- a. It is important that our Sailors receive all the benefits to which they are entitled. COs must ensure correct application of guidelines per references (a) through (e).
- b. Personnel in pay grades E-1 through E-5 must have completed enclosures (1) through (3), routed through their chain of command to the NAVSTA Everett UH Office (for review and occupancy level determination) and NAVSTA Everett CO for final determination. The UH Office will provide documentation required for submission to NAVSTA Everett CO to make the final determination.

- c. Members collecting BAH-S who are reduced in rank to paygrades E-1 to E-5 are required to submit enclosure (1) to request a continuance of BAH-S.
- d. Personnel in pay grades E-1 to E-3 on shore duty and all (sea/shore) E-4 over four years can request to be put on the BAH-S waiting list maintained by the Housing Manager and must provide evidence of required financial counseling by their Command Financial Specialist by completing enclosure (2). If utilization is not at 95 percent, eligible members will be placed on a BAH-S waiting list. Spaces occupied by GBs will be considered available when determining occupancy percentage. When utilization reaches 95 percent or greater, the Housing Manager will contact personnel to begin the process to receive BAH-S.
- e. The effective date for payment of BAH-S will be authorized upon submission of an approved BAH-S request form signed by the NAVSTA Everett CO or designated representative. Any requested back dating of BAH-S start dates of 90 days or more requires a justification letter from the requestor's commanding officer. The effective date will be the date of the document most recently approved (the latter between the two) or "upon check-out of UH" if still residing in Unaccompanied Housing. Upon final determination, NAVSTA Everett Administration will forward enclosure (4) to the affected commands, with a copy to PSD Everett.

NOTE: To avoid a financial hardship, it is highly recommended that personnel do not obtain a residence (to include signing a lease) until authorization for BAH-S has been granted. Checking out of the UH prior to submitting a request for BAH-S is neither required nor encouraged.

- f. Requests recommending disapproval will be forwarded to the NAVSTA Everett CO for final determination. Appeals can be made in writing via the chain of command to the NAVSTA Everett CO.
- 7. <u>Records Management</u>. Records created as a result of this instruction, regardless of media and format, must be managed per Secretary of the Navy Manual 5210.1 of September 2019.
- 8. Review and Effective Date. The NAVSTA Everett Administrative Officer will review this instruction annually on the anniversary of its issuance date to ensure applicability, currency, and consistency with Federal, Department of Defense, Secretary of the Navy, and Navy policy and statutory authority using OPNAV 5215/40 Review of Instruction. This instruction will be in effect for 10 years, unless revised or cancelled in the interim, and will be reissued by the 10-year anniversary date if it is still required, unless it meets one of exceptions in OPNAVINST 5215.17A, paragraph 9. Otherwise, if the instruction is no longer required, it will be processed for cancellation as soon as the need for cancellation is known following the guidance in OPNAV Manual 5215.1 of May 2016.

- 1. Per reference (a), respectfully request permission to draw Basic Allowance for Housing-Single (BAH-S). 1 understand vacating Naval Station (NAVSTA) Everett Unaccompanied Housing (UH) is required prior to receiving BAH-S. I further understand that I must verify my eligibility for BAH-S prior to agreeing to a lease/purchasing a residence and vacating the UH.
- 2. If approved, requested start date is 14 Feb 2022.
- 3. To initiate the payment of BAH-S, I must obtain verification of non-residency and final BAH-S authorization and forward to Personnel Support Detachment Everett.
- 4. BAH-S requests may be disapproved when adequate government quarters are available. Once approved, BAH-S will not be rescinded due to low occupancy and subsequent availability of quarters.
- 5. Disapproved requests will be held indefinitely until eligibility criteria have been met.
- 6. I understand that my BAH-S will cease if:
 - a. I am in a disciplinary status and placed on restriction while onboard Naval Station Everett.
 - b. For any reason, I terminate my residence and move back into any government quarters.
 - c. I am transferred permanently (PCS) outside of the geographic area.
- 7. I further understand that if my BAH-S is terminated for any of the above reasons, it will be necessary for me to resubmit a new request before I may start receiving BAH-S again.
- 8. I certify that once my request is granted, I will notify my Commanding Officer/Officer in Charge of any change of status, which may affect my eligibility for BAH-S.
- 9. I understand that knowingly presenting a false request for BAH-S is a violation of the Uniform Code of Military Justice and that I will be subject to severe administrative actions.
