During Capstone review, the service member's ITP, CRS deliverables, and DD Form 2648 will be checked to identify gaps, and determine if the member is at risk of not meeting the CRS before separation, retirement, or release from active duty.

JOINT SERVICES TRANSCRIPT (JST)

Your JST is an academically accepted document approved by ACE to validate your military occupational experience. The JST also includes military courses you completed, descriptions of military occupations, and college test scores.
